Grooming Client Registration

The animal is fit and healthy. Any grooming which takes place on an elderly animal or animal with health problems will be at the owners' risk. Grooming` may expose pre-existing health/skin problems for which A Purrfect Groomer cannot be held liable.

De-matting/thinning out of matted hair may cause patchiness and hair loss. We make every effort to comb out mats, but if this becomes too painful for the animal we will exercise the option of shaving. Consent to shave the animal will be sought. If this is an unacceptable option for you, please let us know when you drop off the animal.

Shaving/stripping of pets will dramatically change the pets' appearance and the hair will be very close to the skin. This may expose pre-existing skin complaints. Your permission will be required to perform this service.

It is understood that we are not liable for vet bills that may be incurred from any pre-existing growths that are cut or irritated during the grooming process, unless negligence can be proven. Please advise the groomer of any pre-existing blemishes that might be injured during the grooming process to avoid any problems.

If pet(s) are not free and clear of fleas prior to grooming appointment and oral flea treatment will be administered to the affected pet(s) and added to owner's total.

Due to limited space, any pet(s) left longer than 6 hours (from point of drop-off) boarding fee per pet will be added.

Check out time weekdays (Tues-Friday) is 6:30pm, weekends (Saturday) is 5:30pm. Picking up after check out time will result in boarding fee (per pet) and will be added to owner's total.

Uncollected pets left past posted closing hours will be charged a sitting fee. \$8.00 every 15 minutes after closing time.

Owner specifically represents to A Purrfect Groomer that their pet(s) have not been exposed to rabies or distemper as precautionary owner will verify true by providing a current RABIES & DISTEMPER CERTIFICATE (and or health certificate).

Owner agrees to pay for services provided by A Purrfect Groomer date pet(s) is brought in for services, regardless if services were not complete.

Owner certifies the accuracy of all information given about said pet(s).

Owner further agrees to be solely responsible for any and all acts or behaviors of said pet(s) while under care of A Purrfect Groomer.

This contract contains the entire agreement between the parties. All terms and conditions shall be binding on the heirs, administrators, person representatives and assigns of the owner and A Purrfect Groomer.

Any controversy or claim arising out of or relating to this contract, or breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this contract, shall be settled in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any court having jurisdiction thereof. The arbitrator shall, as part of the award, determine an award to the prevailing party of the cost of such arbitration and responsible attorney's fee of prevailing party.

Section 1-1834.5. § 1834.5. Abandonment of animal delivered to veterinarian. Notwithstanding any other provision of law, whenever any animal is delivered to any veterinarian, dog kennel, cat kennel, pet-grooming parlor, animal hospital, or any other animal care facility pursuant to any written or oral agreement entered into after the effective date of this section, and the owner of such animal does not pick up the animal within 14 calendar days after the day the animal was due to be picked up, the animal shall be deemed to be abandoned. The person into whose custody the animal was placed for care shall first try for a period of not less than 10 days to find a new owner for the animal, and, if unable to place the animal with a new owner, shall thereafter humanely destroy the animal so abandoned. Owner specifically represents that he/she is sole owner of the pet(s) free and clear of all liens and encumbrances.
